**THE SEMINAR.** The training seminar will be held at Lavelle Farms, in Southeastern Ohio six miles off of SR 32 from Albany, Ohio on Thursday-Friday on January 11-12, 2007 just before the January 13-14, 2007 Buckeye Cow Dog Association stock dog trial. [www.buckeyecowdog.com](http://www.buckeyecowdog.com) Four sessions(a.m\p.m.) will be held over the two day seminar. The seminar will be held from 8:00 a..m. through 5:00 p.m.

The cost is \$225.00 per person with one dog for all four sessions over the two seminar days. Only 8 working spots will be available for the seminar. Auditors\spectators are encouraged and welcome. The cost is \$40.00 daily. Each participant in the seminar should plan on using **the same dog** for all four sessions. There are only a limited number of dogs being accepted to allow for more individual attention. Dog broke cattle and sheep will be available for the seminar. The 120' x 200' indoor arena will be used which has a heated spectator area. On-site concessions and indoor rest rooms as well as camper hook-ups are available, so the seminar will go forward regardless of weather. Camper hook-ups are \$10.00 per night.
